JOKERS BY SLAM

One of our most ambitious projects will be Jokers By SLAM. World's first oracle-powered & customizable NFT collection. Truly dynamic NFTs that are provably rare. Here is the latest around Jokers by SLAM:

- Only 8,888 pieces will ever be minted.
- Mint price will be 0.07 ETH for each piece.
 - 5 mints bundle will cost 0.3 ETH in total. (0.06 ETH per each)
 - 10 mints bundle will cost 0.5 ETH in total. (0.05 ETH per each)
- \$1,000,000 buyback fund will be created for SLAM from the public sale and future royalty revenues combined.
- SLAM Billionaires will be eligible for free NFTs if they don't transfer/sell any SLAM from today until the minting date. We have taken a snapshot already but to double check transfers. But the main snapshot where we will check who is eligible to receive free NFTs will be taken on 5th of March.
 - 1B to 2B —> 1 Joker
 - 2B to 4B —> 2 Jokers
 - 4B to 10B —> 3 Joker
 - 10B or more —> 4 Jokers

Marketing will be heavily done through our NFT Radar App to thousands of new investors. Jokers will also have its own Twitter for us to promote it separately than SLAM Ecosystem. New discord channel has been created for Jokers which will be the main source of information regarding Jokers.

The trade name "Curaçao eGaming" or "CEG" is owned by Cyberluck Curaçao N.V. ("Cyberluck"), a private limited company, incorporated on March 15th, 1998 in Curaçao. Cyberluck is licensed by the Government of Curaçao since October 1st, 1998 under license reference 1666JAZ to offer games of chance, including the right to under regulatory obligations grant the said offering to third party IP-operators, commonly known as "third licensing". The Public License Certificate is a separate, public certificate, listing the information of sole single domain and its Alternate Designations ("ADs") for compliance purposes. It is valid for public display within the "Header" and all the said domain and its ADs only and cannot be used for any purposes of certification, other than to provide assurance to players ("End Users") that the website is under compliance oversight by CEG. To safeguard that certified operators have remained legitimate, this certificate expires and needs to be renewed on a quarterly basis. For Business-to-Business ("B2B") verification purposes, an additional, License Verification Certificate ("LVC") is required. The certificate does not allow at any time the holder to authorize other parties to offer games of chance, commonly known as "third licensing". Any abuse of the certificate shall lead to a formal complaint by CEG, held in all relevant jurisdictions. CEG, under no circumstance grants license that have not been approved by the board of directors by the licensed IP-Operator. By law, only locally formed companies (B.V. or N.V.) may hold a sublicense. No Curaçao entity may operate under a foreign license. Only CEG may grant authority to other games of chance licensees to sublicense. CEG may at any time revoke its licenses. The Public License Certificate is only displayed on the "Header" field. A double or hard copy is not delivered valid. For fraud prevention purposes, no digital third party validation systems are allowed. You can check slamvegas.com/validate to verify our license from Curacao eGAMING which is officially one of the 4 master license holders in Curacao that issues licenses to online casinos. After a 6-months application process we can now kick off our operations under our license in allowed countries.



LAUNCH STRATEGY

We will do a soft launch on February 6th, 2022 for SLAM VEGAS. Meaning the first couple of weeks we will do a lot of tests, improvements according to your feedback. It won't be like a beta version but just a transition period for the grand opening.

We have allocated a decent marketing budget for Vegas, which will be used once we know platform can handle mass traffic.

Since acquiring our license we have been able to communicate with industry leading influencers, streamers and of course gamblers to promote Vegas in allowed jurisdictions. More details will be shared on this.

Except for slots, we will have all the casino games, live or auto from a variety of gaming providers including Evolution and Pragmatic Play. Slots will be launched a bit later.

There will be USDT gameplay only. But you will be able to deposit multiple major cryptocurrencies. We will automatically convert your deposit into USDT for you to start playing.





SLAM CRASH v3

We are still working on the v3 of our beloved crash game. Since we prioritized Jokers and Vegas, we have delayed the launch of v3. But it is still work in progress and we aim to launch it in Q1 2022. Some of the planned features include,

- New deposit/withdrawal mechanism. Newly created wallets for each player for faster cashier transactions.
- 5 new partner tokens.
- USDT, DOGE, BTC, SOL payment methods addition.
- Daily Bonus Rounds where players get back their original bets after the round ends. Affiliate - auto bet - charity - tip - more engaging - dynamic bankroll investment - translations - themes

SLAM ROYALE

Just like Crash, Royale is also being improved and developed as we speak. There is a dedicated developer we hired for Royale and we aim to relaunch it in early Q2. Some of the features include,

- USDT gameplay only. We will still allow BNB deposits and also we will add ETH, BTC, DOGE deposits/withdrawals.
- Weekly tournaments will take place. Every week there will also be free-to-enter table where we will attract new players.
- Owning a Jokers by SLAM NFT piece will be the only way to showcase an avatar on Slam Royale.
- 35% of the profit will continue to be sent to Slam Pools.

MORE UPDATES

- Core benefit of holding SLAM has been receiving your dividends. Our ultimate goal is to make sure we use everything in our power to increase the payout size for our eligible holders. So far Crash has been the only source of income for the payouts. But with the launch of Vegas and Jokers this is changing.

There will be a \$1,000,000 buyback fund created from the public sale of Jokers and future royalty revenues. And 35% of all the profits for Vegas will be going to Slam Pools. With these 2 major goals in place there hasn't been a better time to buy and hold SLAM.

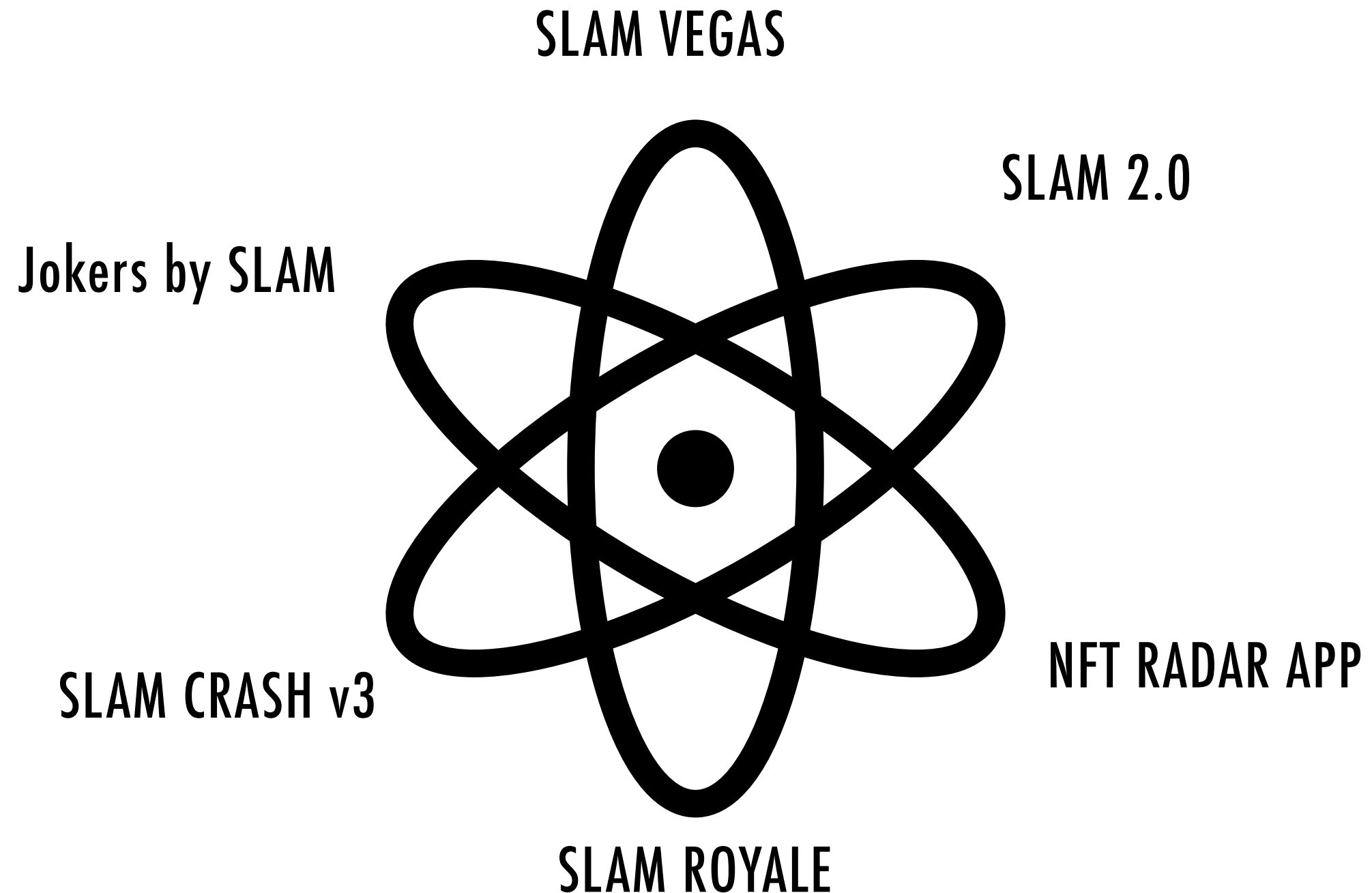
Taking into account the current crash volume for SLAM gameplay and our plans to turn SLAM Crash into a BNB & ETH oriented game in the near future, we will not be distributing any more SLAM profits. Instead any SLAM profit will be locked forever, meaning circulating supply will shrink over time.

BNB dividends will continue to be distributed and with Vegas we expect to multiply our bankroll profits so bigger payouts for everyone!
